APPLICATION UNDER SECTION 4 OF THE BELONGING LAW

To be filled out by members applying to M'Chigeeng First Nation Belonging Law who are entitled and have a right to belong (ie. 181 number and who did not receive their 181 number until after 2019). M'Chigeeng Belonging law section Section:

4) *Persons entitled to citizenship as of Right.*

- a) The following persons are entitled to Citizenship in M'Chigeeng Anishinaabek:
 - i) Indigenous persons, of any age, whose names appeared on the INAC Affiliated Band List maintained by the Department for the M'Chigeeng Band or were entitled to have their names on the list immediately prior to this Law coming into force; or
 - ii) A person, of any age, with at least one (1) biological or adoptive parent who is, or, if no longer living, was listed or entitled to be listed on the Citizenship Register as Citizens.

Please note that under Section 4, this application process is a formality. Nobody will be denied Citizenship.

The Citizenship Committee will meet within (30) days of receipt of this application.
