FINAL CANDIDATES SUBJECT TO CHANGE

To become a candidate, duly nominated and seconded Nominees must deliver the following document to the Electoral Officer by **April 11, 2026**:

1. An Acceptance of Nomination Form for one (1) council position only.

In addition, Nominees must deliver to the Electoral Officer by **April 18, 2026**:

1. A Criminal Record Check; and
2. A signed consent form authorizing the Nominee's criminal record to be made available for review by the membership.

Where a Nominee has resided in more than one jurisdiction, the Nominee must file a criminal record check for each jurisdiction. A criminal record check must include the period up to and including the date of the Nomination Meeting, April 4, 2026.

Employees of the M'Chigeeng First Nation are eligible for nomination as candidates but must resign or take a leave of absence from such employment before accepting a nomination. A leave of absence must encompass the period of candidacy and any term of office actually served as a council member as a result of the election.

If the above requirements are not received by the Electoral Officer by the **stated deadlines**, the Nominee will not be a candidate in the 2026 M'Chigeeng First Nation Election.

In accordance with the *M'Chigeeng First Nation Custom Election Code (2019)*, a candidate may withdraw from candidacy at any time before acclamation or the close of the polls by providing the electoral officer with a written withdrawal of nomination signed by the candidate in the presence of the electoral officer, a justice of the peace, a notary public or a commissioner for taking of oaths. A Withdrawal Form is included in the *Candidate Requirements Package*. If a candidate withdraws before the printing of ballots has begun, the candidate's name will be removed from the ballot. If a candidate withdraws after the printing of ballots has begun, the candidate's name will remain on the ballot, but votes cast in favour of that candidate will be disregarded for all purposes.
